PARENT / GUARDIAN STATEMENT OF COOPERATION

It is my intention to educate my child under the auspices of Westgate Christian Home Education Association (as provided for under Title 59 - Education, Chapter 65. Attendance of Pupils, Article 1. Compulsory Attendance, Section 59-65-47). I agree to provide all information to Westgate Christian Home Education Association that is legally required under the South Carolina state law listed above.

It is my intention to pay fees when due and to pay tuition (if taking any courses with Westgate Christian School) on or before due date. Report cards and transcripts are not released if the account is past due. I understand that if my account becomes 30 days past due, my child or children may have to be suspended until the account is brought current.

If applicable, I give Westgate Christian Home Education Association and/or Westgate Christian School permission for my child to take part in all organized activities, including bus trips, sports activities, and school/association sponsored trips away from school premises.

If I am disturbed with some policy or practice of the Association or School, I will speak first to the teacher, and finally to the administrator, rather than to other parents. If I cannot continue to support Westgate, I will withdraw my child without seeking to undermine or discredit the ministry or its personnel.

I will inform the office of any changes in the following: address, personal phone numbers (home, cell, beeper, or employer), persons (with phone numbers) authorized to pick up my children, other emergency numbers, medical information, and the custodial status of my children.

Should legal action for any reason be taken against Westgate Baptist Church, Westgate Christian School, or Westgate Christian Home Education Association, or any employee or agent thereof on my child's behalf, and if the school or its agent not be found at fault, I agree to pay any attorney fees, court costs, damages, or other costs that Westgate or its agent should incur to defend itself against such actions.
